- c. Any member under the age of 28, in good standing in attendance at the AM of the GB or who has provided a letter of intent prior to the AM, shall be eligible for a selective office, but she shall be eligible from only one (1) Bethel.

- b. Any elective officer must be at least sixteen (16) years of age at the time of installation. Exception: GB Recorder, GB Treasurer, and GBHQ must be at least eighteen (18) years of age at the time of installation. The GBHQ must be no older than <a href="twenty-five">twenty-five</a> (25) years of age at the time of installation.
- c. Any member under the age of **twenty-five** (<u>25)</u>, in good standing in attendance at the AM of the GB or who has provided a letter of intent prior to the AM, shall be eligible for a selective office, but she shall be eligible from only one (1) Bethel.
