

Dear Bethel Guardians,

We have established a new award this past year during Grand Session, the Lily of the Valley Award. This award was modeled after one by the same name from Supreme. This has been established as a way of recognizing those older daughters and younger Majority members that continue to have a meaningful impact within their Bethel and Job's Daughters. As these young ladies begin to transition into new aspects of their lives, they could look for other opportunities to highlight their talents, however; they continue to contribute to furthering the objectives of Job's Daughter's by becoming role models to our members. To qualify for this award the Daughter or Majority Member should have shown outstanding dedication to both her home Bethel and JDI by continuous, meritorious service to the order.

To be eligible for this award:

1. The Nominee must be either an active member or Majority Member of JDI
2. At the time of her nomination, she must be at least eighteen years of age and not older than twenty-four years of age
3. If the nominee is a PHQ, she must have completed her term as HQ at least two years prior to her nomination

Nominations can be made by an executive member of the BGC without the knowledge of the nominee. Nomination shall include specific examples of outstanding service to the Bethel. In addition to the nomination, recommendations in writing from four adults not related to the nominee, who have first-hand knowledge of her contributions to the Bethel, shall be submitted. Nominations may be made by the nominee's home Bethel or another Bethel in which she has made outstanding contributions that would merit the nomination.

The proper conferral of the award is at the Annual Meeting of the Grand Bethel. If the recipient is unable to attend the Grand Bethel meeting the award can be conferred at a regular Bethel meeting, jurisdictional or open event. The award must be conferred upon the recipient with two years of her approval.

A fee amounting to the cost of the medallion will need to be paid for by the recipient, her family, her Bethel, or anyone else who is willing to contribute. This fee must be paid to the Grand Guardian Council prior to receiving the medallion for the presentation of the award.
